CAYUGA COUNTY WATER AND SEWER AUTHORITY

Doug Selby and Greg Mosher from CCWSA presented the board with information regarding the water and sewer infrastructure. The Village of Aurora has been put on notice by Wells College that they will be ceasing the water supply to the Village of Aurora in the future. Options for water sources could be a 6 mile (30,000' @ \$80/\$85 per foot installed could be several million dollars) pipeline from Union Springs where they currently have pumps and additional equipment. The funding cycle is annually. The funding is awarded in the fall and if this project were to move forward, it would be approximately 2-3 yrs (2020-2021) before "breaking ground". Wells does currently have a crash program to go in effect in August. Grants are prioritized (year round vs. seasonal residents). More grants are available after 2016 Algae Bloom problems.
