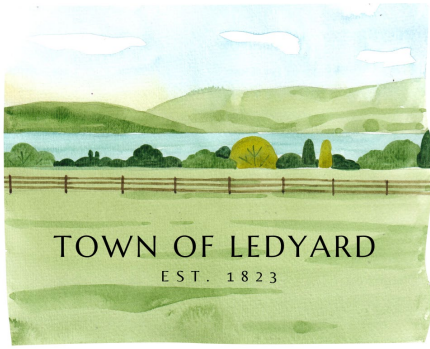

Cayuga County Water and Sewer Authority

Board Member Anne Reynolds has spoken to Dave Eckhardt and was asked to mention to the board about signing a letter of support. The Authority has been notified by Congresswoman Tenney's office that the Project has been selected to receive a Community Funding Grant for 2025. The project is referred to as the Cayuga Lake Protection Plan for the Southern Cayuga Sewer District. With this initiative, the Authority will receive a 2.5 million dollar grant. More information on the grant can be found on the congresswoman's website. Also, there are requests to Congressman Schumer's office and Senator Gillibrand's office. The Authority will be submitting funding applications on 6/14/24 to EFC. Supervisor Jordan stated that he would not be signing the letter but if other board members wanted to, they could. A motion was made and seconded that the Ledyard Town Board supports the Cayuga Lake Protection Plan, and following discussion the motion carried by a vote of four in favor and one opposed.

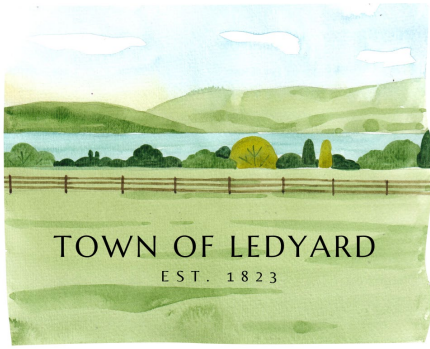

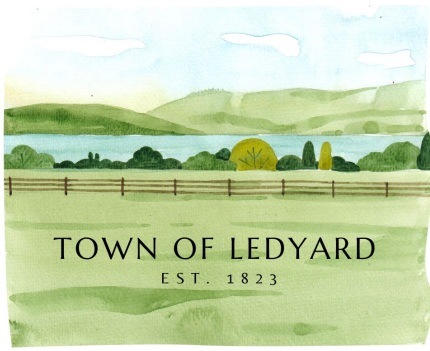

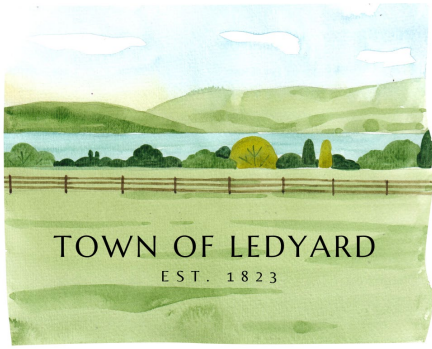
